PROCESSING CONDITIONS

To avoid residual humidity from transport or storage, the material should be pre-dried approximately 2h at 80°C.

Following parameters should be used as guidelines:

Holding pressure	50% - 70% of the injection pressure
Mould temperature	30 - 50°C
Injection mass temperature	220 - 260°C
Injection speed	Low to medium
Screw speed	Slow to medium

- Injection machine barrel must be cleaned carefully during startup to remove possible degraded remains and impurities.
- Shot size is suggested to be kept at 30-70% of machine shot capacity to avoid long material residence time.
- Lower shear rate of plastic material is recommended to achieve lower VOC and odour. Injection speed is
 recommended to be kept at lower level if part filling is not an issue. Bigger gate size is recommended
 and try not to use small pin point gate and banana gate.
- Upon successful filling without appearance defect, low barrel temperature is preferred to achieve lower VOC.
- Avoid using mould release or lubricant agent during moulding process, which will possibly generate undesirable volatiles and odour.

Specific recommendations for processing conditions can be determined only when the application and type of equipment are known. Please contact your local Borouge representative for such particulars.

STORAGE

Daplen EF011AIC should be stored in dry conditions at temperatures below 50°C and protected from UV-light. Improper storage can initiate degradation which results in odour generation and colour changes and can have negative effects on the physical properties of this product.
