# **DESCRIPTION**

**Fibremod GB306SAFC** is a 35 % chemically coupled high performance glass fibre reinforced polypropylene compound intended for injection moulding. The product is available in standard black 9502.

This material shows excellent mechanical properties at elevated temperatures.

#### **PROCESSING CONDITIONS**

The actual conditions will depend on the type of equipment used.

This product is easy to process with standard injection moulding machines. To avoid residual humidity from transport or storage, the material should be pre-dried approximately 2h at 80°C.

Back pressure Low to medium
Screw speed Slow to medium
Flow front speed 100 - 200 mm/s

#### **STORAGE**
