Description

Bormed™ RB801CF is a polypropylene random copolymer intended for evaluation for use in Healthcare applications.

This grade is suitable for the manufacturing of films using cast film as well as tubular water quench blown film extrusion technology. Bormed™ RB801CF can also be processed in blow moulding, including blow-fill-seal (BFS) technology, ISBM and IBM (1-stage process) for ampoules and bottles up to a maximum of 2 litres.

The Bormed™ concept is based on the three core principles of service, commitment and conformance which cover the different aspects of active information management, change control and security of supply. Because we care.

As part of the Bormed™ product portfolio, in case of notifiable change the grade can be made available up to 5 years (2 years pre-notification and last call volume with 3 years shelf life); subject to mutual agreement.

Processing techniques

Bormed™ RB801CF is easy to extrude and can be used in all conventional blow moulding machines. Following parameters should be used as guidelines:

Processing setting	Typical value/range
Barrel temperature	190 - 220 °C
Die temperature	180 - 220 °C
Melt temperature	180 - 220 °C

Packaging and storage

Bormed™ RB801CF should be stored in dry conditions at temperatures below 50°C and protected from UV light. Following aforementioned conditions the material can be stored for a period of up to 3 years after production. Improper storage can initiate degradation, which results in odour generation and colour changes and can have negative effects on the physical properties of this product.
